

COMMUNITY PHARMACY IN HEALTH CARE HOMES TRIAL PROGRAM

Operational Workshop

Those pharmacies within close proximity to a General Practice or Aboriginal Community Controlled Health Service (ACCHS) that are participating in the Health Care Homes trial program will be provided with an opportunity to participate in an operational face-to-face workshop.

These workshops are designed to support community pharmacies in the delivery of *the Community Pharmacy in Health Care Homes Trial Program* and will be co presented by Guild Learning and Development and the Pharmaceutical Society of Australia (PSA) in conjunction with the Primary Health Networks that are participating in the broader Health Care Homes Trial.

Included as part of these workshops each participating Primary Health Network will be providing an information session to the broader Health Care Homes practice teams within their catchments which will include interested GPs, nurses, care coordinators, practice managers and other staff.
